Fun Classes with Special Awards:

FC1: Mounted Musical Chairs - Chairs will be represented by Orange Cones. Music is played and everyone goes around the ring **until** it stops. When it stops, get to a cone. The trick is, there will always be one less cone than riders. If you don't get to a cone in **time**, you're out. The rider at the last cone is the winner!

FC2: Red Solo Cup - Every rider will be given water in a red solo cup to hold in one hand. Directions for walk/trot/canter/**sitting** trot/etc will be given. The person with the most water **still** in their cup at the end wins!

Dressage Classes	\$30

Non-OVCTA members	add \$10 to total Entry
Late entries	Add \$10 per Late Fee Policy (see below for policy)

NOTES:

- **ASTM/SEI HELMETS ARE REQUIRED FOR ALL COMPETITORS AT ALL TIMES WHILE MOUNTED.**
- Dressage TOC - will be used for all dressage tests not already represented by an offered class.
- Event TOC - come & practice the 2014 Eventing dressage tests! Test readers ALLOWED.
- Western Dressage TOC - Using the WDAA Tests. Please specify what test on entry.
- Main dressage arena/ring will be OPEN during scheduled breaks and lunch for schooling, warm-up and hand walking. There will be scheduled open warm-up sessions IN THE RING!

ENTRIES: Organizer reserves the right to combine, split or cancel classes or divisions as necessary and to refuse an entry for any reason. Entries are not complete without the Coggins and all signed entry/release forms. No one will be allowed to compete without all signed releases. All minors MUST have their release forms signed by a parent or legal guardian.

REFUND POLICY: Full refunds given before closing date by contacting the organizer. After the closing date, refunds will be given if the entry can be filled from wait list, minus \$10 fee. Vet/MD cert.

LATE FEE POLICY: Entries must be RECEIVED (not postmarked) by the closing date. Late entries will be accepted at the discretion of the show organizer. A \$10.00 late fee will be added if necessary and payable before the rider may compete. Incomplete entries may be placed on a waiting list.

AWARDS:

- Dressage Classes - 6 ribbons awarded per dressage class.
- USDF Level, Training Level, First Level & Above High Score Ribbons awarded.
- Ribbons and special prizes for the fun classes too!

TIMES: Times will be available on Thursday prior to show posted on website:

www.ovcta.org or can be emailed if email address is provided on the entry form.

If no web/email access, please provide a current phone number on entry form.

ARENAS: Sand arena measures 20x40 for all USDF & USEA tests, 20x60 sand arena for all others.

Warm-up will be held in the flat grass warm-up area & in ring. No lungeing in warm-up area please.

ATTIRE: As for schooling show. Hawaiian shirts highly recommended! Neat, clean & workmanlike.

Breeches, boots or jods. ASTM/SEI approved helmet REQUIRED for all riders at all times while mounted. Jackets & braiding? NO WAY DUDE! Please keep safety in mind for the Beach Costume Class. Tack & equipment as for recognized competition. Boots on your horse are OK for warm-up area but they must be removed prior to entering the show ring. All other USEF rules apply.

OTHER INFO: Limited food & drink available day of show. All dogs & wayward children must be leashed or left at home please. Please bring a muck tub for cleanup around your trailer and take manure home. Please be courteous to all volunteers, officials and fellow competitors. Please follow safe practices while in the warm-up ring. Port-a-pot will be provided for competitor use.

DIRECTIONS: From Rt. 100, go West on Rt. 23. Go to third road on left (1.7 miles) and turn left onto Mt. Pleasant Road. Go over bridge and to third driveway on right. Orange cones will mark the entrance.
