About Jenny

Jenny Caras has enjoyed incredible success during her career thus far. Jenny began riding at the early age of four years old and by the age of 21 was one of the youngest riders privileged to ride at the **Rolex CIC4* in Lexington, KY in 2017**. In 2010, Jenny competed in the North American Jr & Young Rider Championships CH-J1" on her mount Raku. In 2013, she won **Team Gold and Individual Bronze medals** at the NAJYRC CH-Y2* with Fernhill Stowaway. In 2015, Jenny placed 6th in the Jersey Fresh International CIC3", 4th in the Bromont Canada CCI3" and received the Markham Trophy as the highest placed **Young Rider in the Fair Hill International CCI3*** with Fernhill Fortitude. At the end of an incredible 2015 season, she received the Essex Grant and was awarded the Karen Stives Grant which allowed her and Fernhill Fortitude to travel to England and compete in the under 25 division at Bramham where they finished in ninth place amongst a very competitive field. Also in 2016, she was chosen for the fourth consecutive year as one of the **10 top riders in the United States to be named to the USEF Eventing 25 Training List**. Jenny currently trains with Phillip Dutton.

Jenny is an established instructor and an inspiration to riders of all ages!
